<p><b>Lamar CISD Bond 2022</b> Dr. Roosevelt Nivens</p> <p><i>30 minutes</i></p>	<ul style="list-style-type: none"> <li>• Bond 2022 - \$1.7 Billion bond - <a href="https://www.lcisdbond2022.org/">https://www.lcisdbond2022.org/</a></li> <li>• Dr. Nivens shared demographic updates from PASA – growth has surpassed projections from the demographers</li> <li>• A Rated School District, Certificate of Excellence in Financial Reporting by TASBO</li> <li>• Elementary Growth – in next 9 years we will need 17 campuses to keep up with the growth</li> <li>• Secondary Complex #8 part of bond</li> <li>• Dr. Nivens’ goal is to get out of the portable business – we have 10 campuses worth of portable buildings in our district</li> <li>• Purple track is where the growth is being felt the most</li> <li>• Click here to access handout covering what is in each proposition <ul style="list-style-type: none"> <li>○ Proposition A – Safety and Security Updates, New Campuses, Bond 2020 Inflation Costs</li> <li>○ Proposition B – CTE Center</li> <li>○ Proposition C – Technology Equipment</li> <li>○ Proposition D – Traylor Stadium LED Lighting and Turf</li> <li>○ Proposition E – Second Stadium</li> </ul> </li> <li>• Tax Impact – If taxable values continue to grow of a rate of at least 8.11%, we will not need to raise tax rate <ul style="list-style-type: none"> <li>○ Video Dr. Nivens created explaining tax rate compression can be found on the bond website</li> </ul> </li> <li>• Early Voting – October 24 – November 4</li> <li>• Election Day November 9</li> <li>• Adjustments are being made to secondary purple track campuses for the 23-24 school year to support families with growth –handout will be shared on district website after purple track town hall</li> </ul>
<p><b>Superintendent Q&amp;A</b> Dr. Roosevelt Nivens</p> <p><i>10 minutes</i></p>	<ul style="list-style-type: none"> <li>• We are currently short 45 bus drivers – will likely need to explore different school start times next year</li> <li>• Have we reconsidered letting the security guards go at the start of the 2023-2024 school year with the additional portables? <ul style="list-style-type: none"> <li>○ The current security officer positions will be replaced with certified police officer or security officer at lower salary.</li> </ul> </li> <li>• \$500 retention stipend was given to all returning classroom teachers <ul style="list-style-type: none"> <li>○ If additional funds become available after PEIMS snapshot, instructional support staff would be next tier to be given stipends, followed by custodians, bus drivers, etc.</li> </ul> </li> <li>• Ask any question you need the answer to but talk to your principal first. Our job at central office is to support you!</li> </ul>
